THE ETHEL AND SAMUEL J. LEFRAK SCHOOL SERVES PRESCHOOL CHILDREN AGES 3-5 WITH VISION IMPAIRMENTS AND DEVELOPMENTAL DISABILITIES, AS WELL AS SIGHTED CHILDREN WITHOUT DEVELOPMENTAL DISABILITIES. SERVICES FROM TEACHERS OF THE VISUALLY IMPAIRED, OCCUPATIONAL THERAPY, PHYSICAL THERAPY, AND SPEECH THERAPY ARE AVAILABLE. THE LEFRAK SCHOOL HAD 107 STUDENTS FOR THE '15-'16 SCHOOL YEAR. DURING 2016 THE PROGRAM WAS CLOSED AND A NEW MODEL WAS DEVELOPED TO PARTNER WITH "ADAPT". A LGI TEACHER FOR VISUALLY IMPAIRED IS PLACED IN "ADAPT'S" PRE-SCHOOL. THE NEW MODEL DEVELOPED A TEACHER TRAINING PROGRAM WITH LGI'S PROFESSIONAL EDUCATION AND EXPANDED LIGHTHOUSE GUILD'S REACH.
